		1.	Original	<b>This checklist</b> , with boxes ticked and documents in the sequence of this checklist.
		2.	Original	Print-out confirmation email, that you have an <b>appointment</b> for your visa application.
		3.	2 Originals	Two <a href="#">visa application forms</a> properly completed. Signed and dated in field 36 + 37 as well as on the last page of the form.
		4.	3 Originals	Three <b>recent</b> passport-sized <b>photos</b> according <a href="#">to the ICAO regulations</a> .
		5.	Original + 2 Copies	<b>Passport</b> with at least three empty pages. Issued less than 10 years ago and valid for at least 12 months at the point of visa application. Copy of bio-data pages (this includes the signature page) + previous Schengen visas.
		6.	Original + 2 Copies	<b>Malaysia resident permit</b> Employment pass/Dependant's pass/Work permit/Student pass/Permanent Resident card + Re-entry Permit/...
		7.	Original + 2 Copies	<b>Official copy of your birth certificate</b> (proof that you are over 21 years old) issued less than 6 months ago If it is issued in Malaysia: Extract of Births issued by the National Registration Department in Malaysia, authenticated by the Ministry of Foreign Affairs in Malaysia and legalized by the Embassy. (fees apply) See <a href="#">procedure of legalization of documents</a> , if document was issued abroad.
		8.	Original + 2 Copies	<b>Official copy of your marriage certificate</b> , issued less than 6 months ago If it is issued in Malaysia: Extract of Marriage certificate (for Civil marriage) and Certificate copy (Religious marriage), authenticated by the Ministry of Foreign Affairs in Malaysia and legalized by the Embassy. (fees apply) <b>Official copy of the divorce certificate or judgement</b> (if applicable) See <a href="#">procedure of legalization of documents</a> , if document was issued abroad.
		9.	Original	<b>Medical certificate</b> issued less than 6 months ago. It must be properly filled out and stamped and signed by the medical doctor designated by the Embassy. Kindly contact Clinic Segara at +60321632140
		10.	Original	<b>Legalized certificate of good conduct</b> (for 21 years old and above) issued less than 6 months ago by your country of residence or country of origin. <i>To obtain a "Certificate of Good Conduct" in Malaysia, kindly contact the Ministry of Foreign Affairs of Malaysia + legalization by the Embassy of Belgium in Malaysia (fees apply)</i>
		11.	2 Copies	Work Permit / Professional Card / European Blue Card / Host Agreement of your spouse
		12.	Original + 2 Copies	<b>Medical Insurance Certificate</b> issued by the Health Insurer in Belgium (mutuelle / mutualiteit) Proof that your spouse has a health insurance policy covering medical costs in Belgium for him / her and the family / employment contract including a clause regarding health insurance coverage / travel insurance certificate + policy covering all risks and costs (medical and repatriation) in Belgium for at least 30 000 EUR (or its equivalent) and valid for a duration of 3 months.
		13.	2 Copies	<b>Proof of sufficient accommodation</b> of your spouse in Belgium. Lease agreement / employment contract including a clause regarding housing / hotel reservation.
		14.	2 Copies	<b>Proof of your spouse's regular and sufficient means of subsistence</b> Employment contract / letter of the employer including duration of the contract and monthly salary.
		15.	2 Copies	<b>Proof of payment of the <a href="#">administrative fee</a></b> . Only possible via bank transfer and to be paid prior to the visa application. Cannot be paid at the Embassy.
		16.		<b><a href="#">Accepted proof of vaccination</a></b> : You are fully vaccinated 2 weeks after your last vaccination dose with an EMA approved vaccine or Covishield.
		17.		<b><a href="#">Visa fee/Legalization fee</a></b> : Please refer to the link

I HAVE BEEN INFORMED THAT:
